Hindustan Petroleum Corporation Limited (HPCL), a Maharatna public sector company, operates two refineries in Mumbai and Visakhapatnam with capacities of 9.5 Million Metric Tonnes Per Annum (MMTPA) and 13.7 MMTPA, respectively.

HPCL manages a vast network of 5,132 km of cross-country petroleum product pipelines, transporting Motor Spirit (MS), High-Speed Diesel (HSD), Superior Kerosene Oil (SKO), Liquefied Petroleum Gas (LPG), and Aviation Turbine Fuel (ATF). This network includes 3,957 km of product pipelines with a capacity of 31.11 MMTPA and 1,006 km of LPG pipelines with a capacity of 4.1 MMTPA. HPCL's pipeline network spans multiple states and union territories, including Maharashtra, Andhra Pradesh, Telangana, Tamil Nadu, Gujarat, Rajasthan, Haryana, Delhi, Punjab, Uttar Pradesh, and Karnataka.

HPCL plans to lay a cross-country petroleum, oil, and lubricant (POL) pipeline from its Visakh Terminal to the Raipur Terminal in Chhattisgarh. The proposed facilities for the Visakh Raipur Pipeline (VRPL) project include:

- 1. Despatch Pump Station at Visakh
- 2. 540 km cross-country pipeline comprising:
 - a. 374 km, 14" diameter pipeline from Visakh to Kantabanji Depot
 - b. 166 km, 12" diameter pipeline from Kantabanji to Raipur
- 3. Intermediate Pump Stations (2):
 - a. Rayagada Booster Station
 - b. Kantabanji Booster Station
- 4. Receipt Stations (2):
 - a. Intermediate Tap-off at Kantabanji
 - b. End Receipt Station at Raipur

The total project cost is estimated at ₹2,200 crore, with a projected completion in 2027. The procurement plan for the VRPL project includes the following key items/packages:
